

## ELECTION FRAUD COMPLAINT

### ADDITIONAL EVIDENCE OF OUT OF STATE RESIDENT COMMITTING FRAUD IN FLORIDA

Registering to vote in three different counties, filing forms to run for Florida Office and voting twice in Florida Elections while maintaining his primary residence in McClean, Virginia

This additional information shows that Cory Mills documented in his own Public Records filings in Virginia that he was a resident of Virginia during the time he was falsely portraying that he lived in Florida. Even after he was elected, he still claimed his residence as 1198 Windrock Drive, McLean, Virginia.

This information is just a part of more concrete evidence that Mills was a resident of Virginia.

As previously submitted, Mills filed official documents with the Department of State Corporations Commission that he was a resident of Virginia thru out the time he was registered to vote in Florida and he filed paperwork with the Florida Elections Office in 2022, and just 6 days after he was elected, he filed documents with the Commonwealth of Virginia that he was a Virginia resident in November 2022.

### SUPPLEMENTAL INFORMATION

According to the Clerk of the Circuit Court of Fairfax, Virginia, the following official documents are recorded in the Public Records of Fairfax County, Virginia, that show that Cory Mills himself signed under oath that he was a resident of Virginia.

On March 23, 2021, Mills used a DMV in Jacksonville, Florida to change his voter registration to vote in Florida, and claimed he lived at 973 Wilma Ave, Winter Park, Florida. (See News Articles attached on arrest of a politician in Alabama trying to do the same)

On April 1, 2021, Mills filed documentation with the Federal Elections Commission that he was running for Congress in Florida.

On May 7, 2021, Mills filed his first Congressional Financial Disclosure Report with the Clerk of the U.S. House of Representatives.

On June 1, 2021, Mills signed a Credit Line Deed of Trust recorded in Deed Book 27144, Page 0255 of Fairfax County, Virginia. Included in the language of the recording is the following Statement that Cory Mills under oath and signed by a notary of the State of Virginia: ***...” is dated as of May 28, 2021 from CORY MILLS, a resident of Mclean, Virginia and RANA Al SAADI, a resident of McLean, Virginia with their primary residence at 1198 Windrock Drive, McLean, Virginia, 22102 individually and collectively, jointly and severally. “*** (

On 15 June 2021, a Virginia attorney filed a Correction Affidavit of Description Error, and included in the filing was the statement: **...*"Cory MILLS and Rana Al SAADI (grantees), whose addresses are 1198 Windrock Drive, McLean, Virginia."***

On October 11, 2021 Mills re filed the Credit line Deed of Trust in Fairfax County, Virginia saying the same statement: ***"..... is dated as of May 28, 2021 from CORY MILLS, a resident of Mclean, Virginia and RANA Al SAADI, a resident of McLean, Virginia with their primary residence at 1198 Windrock Drive, McLean, Virginia, 22102 individually and collectively, jointly and severally. "***

On February 16, 2022, The Credit Line Deed of Trust was re adjusted. And loan credit extended.

On February 6, 2023, Mills and Alsaadi signed a QUITCLAIM DEED and it was recorded with the Fairfax County Clerk of the Court, Fairfax, Virginia, and included the following signed and notarized statement: ***"...This DEED made and entered into on this 1<sup>st</sup> day of February 2023, by and between Cory Mills and Rana Al Saadi, as tenants by the entirety with common law right of survivorship, residing at 1198 Windrock Drive, West McLean, VA, 22102 hereafter referred to as Grantor(s) and 1198 Windrock LLC, located at 2942 Fairview Park Drive, Suite 350, Falls Church, VA 22042, hereinafter referred to as Grantee(s). "***

This additional information is being provided to show that Cory Mills is in fact a Virginia resident during his campaign, and continued to file official records with the Fairfax County Authorities that he was residing in Virginia.

See News Articles on a similar case in Alabama, this past month where a elected State Representative was pretending to live with a friend, then rent a apartment, etc., but still lived at his out of District home.

**(EXHIBITS 31 and 32 - Kyle Whitmore re State Rep David Cole)**

Cory Mills was without a doubt doing the same thing From March 2021 thru June 2023. Cory Mills and his family were living in Virginia, while Cory was pretending to live in places in Florida. Irrefutable documentation filed in official Virginia shows the real truth about what Mills was intentionally doing.

## **COMPLAINT**

This complaint is being filed based on information that is memorialized in two States, and on Federal Election Website archives. In addition, information was obtained by public information that is available to the public. These allegations pertain to very serious charges of fraud and deception. The acts and incidents occurred in several venues and in two different states. They are as follows:

- Volusia County, Florida, by a Virginia Resident. Date of incident - 27 June 2022

### **FILING OF FRAUDULENT DOCUMENT WITH LOCAL ELECTIONS OFFICIALS BY AN OUT OF STATE RESIDENT**

- Orange, County, Florida, by a Virginia resident. Candidate Petition Fraud – Using a False Address of record. Date of incident. May 11, 2022.

### **FILING OF FRAUDULENT DOCUMENTS WITH THE STATE OF FLORIDA**

- Orange, County, Florida, by a Virginia resident. Candidate Oath of Office Fraud - Using False Address of record and False Residency (Location of Signature and Notary). Date of incident. June 1, 2022.
- Leon County, Florida, by a Virginia resident. Candidate Oath of Office Fraud - Using False Address of record and False Residency (Used Coates Law firm to deliver to the Department of Elections Office) Date of incident. June 10, 2022.

### **FILING OF FRAUDULENT DOCUMENTS WITH THE FEDERAL ELECTIONS COMMISSIONS FROM FLORIDA and VIRGINIA LOCATIONS**

- Orange, County, Florida, by a Virginia resident/Candidate for Congress, Filing False address with the FEC when giving donations to another Federal Candidate, Dates of Incidents. Feb - April 2022.
- Orange, County, Florida, by a Virginia resident/Candidate for Congress, Filing address with the FEC when using both the same Postal Mailing Box (PMB) Address as his Personal mailing address and his Campaign's address.

### **ILLEGALLY VOTING IN THE STATE OF FLORIDA**

- Volusia county, Florida, by a Virginia resident. Illegally voting in a Florida Election while residing in Virginia. Dates of Incidents 23 August 2022 and November 8, 2022 election

These allegations of violating Florida Elections by this out of State Resident impacted the Counties of Duval, Orange, Leon, and Volusia and the State of Florida to willfully and intentionally file documents when he knew at the time that he was filing them that they were made under false pretenses. In doing so he has greatly damaged the citizens and voters of the State of Florida and especially in the counties where he filed them. While at the same time he was perpetrating these acts in various locations in Florida, he was also reporting to The Commonwealth of Virginia that he was a resident of Virginia telling the State Corporate Commission on record that he was and doing the same with tax authorities.

### **FACTUAL BACKGROUND AND EVENTS**

On March 23, 2021 - Cory Mills, whose address of record is 1198 Windrock Dr, McLean, Virginia, showed up at a Division of Motor Vehicles (DMV) location in Duval County, Florida and registered to vote. **Exhibit 1 - Orange County Supervisor of Elections Voter Audit report.** At the time he had no record of ever voting in Florida. Mills told the Tax Collector official at the DMV that he lived at 973 Wilma Ave., Winter Park, Florida. He was given a voter ID number for that specific address. (Note that an additional Records request is pending for a copy of forms, evidence, and/ or digital copy of his memorialized application to register to vote using the address at 973 Wilma Ave., Winter Park, Florida). At the time of his registration, he was still residing in McLean, Virginia and did so continuously thru June 22, 2023. Mills

knew at the time that he resided in Virginia. The tiny Winter Park home that Mills was claiming as his residence was actually owned and occupied by the owners (2 adults and 5 small children) at the time and still remains occupied by them. The home is 1000 square feet in living area, 3 small bedrooms and a tiny half bath and a small hallway bathroom. The home is currently listed for sale. **Exhibit 2 - <https://www.remax.com/fl/winter-park/home-details/973-wilma-ave-winter-park-fl-32789/5314892532536895313/M00000146/O6125742?gallery=true>**.

Interior pictures are available for the public to see. **Exhibit 3 – Pictures of the 973 home published on line.** The owners of the home lived in 1 of the 3 bedrooms and the 5 small children slept in the other 2 bedrooms. Pictures show the living arrangements of the family. The owners claimed the home was occupied from 2017 thru August 2023 and it was not used as a rental property. So, if Cory Mills lived there as a resident, was he a roommate? Did he pay rent? What evidence did he provide the DMV in Duval County, Jacksonville? The Tax Collector of Duval County was told by Mills that he resided there and the SOE of Orange County Florida was notified of his Voter registration using the property. See Orange County SOE Audit Report (**Exhibit 1**) that he did register to vote using the home. on March 23, 2021. Mills ‘s spouse and her two children continuously resided at 1198 Windrock Dr, McLean, Virginia home. **Exhibit 4 – Mills residence 1198 Windrock Dr., McLean, Virginia, Fairfax County.gov.** Mills also told a Associated Press reporter in 2022 the that he lived at both places and spent 70 percent of his time in Florida. Mills told a Politico reporter that he moved to Florida. Mills deliberately knew that he did not reside at the 973 Wilma Ave, Winter Park address. It's obvious that Derick and Vanessa Agustin resided in the small home with their daughters and sons as the bedroom pictures show. The Agustins had the carport enclosed (200 sq feet) without a permit to use as a playroom for the 5 kids and a back yard filled with playground equipment for small children. Mills has no record of registering any vehicles at the Agustin home. No record of paying utility bills at the home. **Exhibit 5 - Winter Park City Utilities.** Mills two sons (ages 16 and 6 at the time) who live in Virginia did not attend any schools in Florida or nearby. From 2017 thru 2023 the Agustins resided at the home according to Tax data sent to the mortgage company. **Exhibit 6 – Orange County, Tax Collector, 973 Wilma Ave, Winter Park, FL.** Mills is on a video with a voter taken in June (July) 2022 stating that he rented the house to the Agustins. **Exhibit 7 – Video clip at Minute 4:51 – 4: 59 of Mills about Winter Park house**

Mills knew that when he made the campaign statement that he was making a false statement to the voters. Mills was

using the Agustin residence to pretend he lived in Florida and that he was a registered Republican there and registered voter there for a year in order to qualify to run for a Florida Office. Mills was (is) also paying Augustin from his campaign.

March 2022 - After one year (March 23, 2021 thru March 2022) it was sometime during the Months of February thru April 2022 that Mills was claiming that he was living in a high-rise building located at 280 S Osceola Ave., Orlando, Florida. However, he never changed his voter registration address to the Orlando location. And he never gave a specific unit number. Mills used the building location at 260 N. Osceola Ave, Orlando, Florida location without specifying an actual address inside the multi residential multi story building. Mills deliberately and with knowing intent left off a specific address of a unit he is alleged to have been staying at on three documents he submitted to the FEC, SOE and to the Florida Elections Office. He used the high-rise location as his official address when he gave donations to another candidate using the building location address. **Exhibit 8 - FEC report extract, 2nd Quarter 2022 for Laura Loomer.** When Mills reported the address on the FEC Donation, he deliberately knew that at the time that he did not reside in the high rise. He did not bother to identify a specific Apartment address within the building. Mills and his spouse and her 2 children still resided in Virginia. Travel history will confirm the allegations.

April 2022 - Mills signed another Candidates petition to get on the ballot. That petition was forwarded to the Orange Supervisor of Elections Office for verification of Mills registered voter information. The petition was rejected for an invalid address on May 11, 2021. **Exhibit 1 - Orange County Supervisor of Elections Office Audit Report.** The Supervisor of Elections (SOE) officials sent a letter to the address Mills used on the petition to verify his actual address. The U.S. Postal Service sent the undeliverable letter back to the SOE. **Exhibit 9 - Returned SOE letter stamped undeliverable addressed to Cory Mills.** See date on returned letter of May 16, 2021.

June 01, 2022 - Just days before the State filing deadlines for qualifying for office, Mills signed and had notarized his Florida Candidate Oath form. **Exhibit 10 – Florida Candidate Oath signed and notarized in Orange County Florida - Cory Mills.** Mills used the entire high rise building location as his Florida residence. Mills never specified a specific address in the multi-story high rise that has over 100 different owners and residents. **Exhibit 11 – 260 S. Osceola Ave, Orlando, Florida.** Mills deliberately left off a specific address on the official Florida form. In addition to that deliberate act another item was penned on the Candidates Oath form that was not correct. Cory Mills used a voter ID number for another address which was false. That Voter ID was assigned to the address where the Augustin's resided at on 973 Wilma Ave., Winter Park, Florida. The Orange County Supervisor of Elections Office had already rejected the Cory Mills Candidate petition he signed with the false information on it just a few weeks earlier. Now the State of Florida Elections office must do the same, now knowing that the Official Notarized State Elections Form that was submitted by Mills contained fraudulent information.

June 10, 2022 - Cory Mills hired and used the Coates Law Firm in Tallahassee, Florida in Leon county to submit the Candidate Oath of Office to the State of Florida Elections Office. The Form contained false and incomplete information.

June 27, 2022 - Within days after Mills submitted the Candidate Oath Form, he changed his voter registration address to a Vacation rental property being rented out and managed by Ocean Properties Management. **Exhibit 13 – Excerpt and audit report for Cory Mills, Volusia County, Florida.** The property was and is still own by Fred and Maureen Adams of Thonotosassa, Florida. **See Exhibit 14 - Tax notice sent to owners Adams.** The vacation Rental Property Management company advertises the monthly rental on the web and has colorful brochures about it available for vacation rentals.

**Exhibit 15 – 2110 Ocean Drive, New Smyrna Beach Vacation Rental Brochure.** There also is a video of the rental. SEE LINK [https://youtu.be/-\\_87tZxXplk](https://youtu.be/-_87tZxXplk). Mills used this address as his new voter registration address on June 27, 2022. The House is completely furnished including towels, wash clothes, toilet paper, toys, etc. A prospective renter was quoted \$16,000 a month to rent the 28-day minimum rental property in December 2022. **Exhibit 16 - Rental quote, 2110 Ocean Drive, vacation rental.**

July 25, 2022 – On the last day to register to vote for the Florida primary, Mills spouse decided to use the same vacation rental property address as her residence too. **Exhibit 17 - Volusia County Supervisor of Elections Office Voter audit report.** There is no record of vehicles registered by Mills or his Spouse at the rental property. The Mills family still resided in Virginia according to Corporation Records filed on the State of Virginia websites **Exhibit 18 – Virginia State Corporation Commission filings from 2015 thru November 2022 (and later).** Travel records show the travel back and forth. Mills is on video stating that he bought a house in New Smyrna. **Exhibit 19 – Video Clip 4:47 – 4:52 June 2022 while campaigning.**

There is no such purchase record filed in Volusia County Property records in existence. The 2110 Ocean Drive house is still owned by the Adams family of Thonotosassa, Florida. Mills was claiming that he resided at the Vacation Rental in late June 2022. Mills did not “move into the house”. There is no evidence that Mills moved his furniture, clothes, and vehicles to the property. His vehicles are still registered in Virginia. Mills stated to a voter that he left his multi-million dollar mansion because he lost his job with the Trump Administration. Its obvious that Mills never left the 1198

Windrock Dr home in 2022. **Exhibit 20 -See Video Excerpt July 2022 made during campaign. 10:26 – 10:34**

23 August 2022 - The primary election was held a month later, August 23, 2022. Mills and his spouse rode to the polls together in a rental vehicle. A recorded video was made of the event.

08 November 2022 - The General election was held on November 8th, 2022. During the entire time between Mills first act of registering to vote in Florida on March 23, 2021 thru the general election Cory Mills maintained his residence and his official residency in Mclean, Virginia. Mills voted in Volusia County, Florida, knowing that he resided in McLean, Virginia. During the entire period Mills continuously let the Virginia State Corporation Commission (SCC) know that he remained a Virginia resident in order to continue to be the official Registered Agent under Virginia law for his LLC. **See Exhibit 21 – Virginia SCC Filings, Pacem Solutions International LLC and Pacem Defense LLC from 2015 thru December 2022.** Mills knew that he was living in Virginia officially during the time he was filing documents and making statements in Florida as described in the afore mentioned facts.

15 November 2022 – Just 6 days after the Florida Elections, Mills solidified his Virginia residency again by filing new Articles with the Virginia Corporations Commission for another Virginia LLC and he stated he was in deed a Virginia resident in order to qualify as the Virginia State Registered Agent for yet another LLC. **Exhibit 22 – Virginia State Corporations Commission filing for 1198 Windrock LLC.** Mills continuously resided at the home with his spouse at 1198 Windrock Dr, Mclean, Virginia from September 2017 thru 2022. They took out Home Equity loans in 2021 and in 2022 and another one just recently in February 2023. **See Exhibit 23 – Record of Fairfax County, Virginia Clerk of Court Records for Property 1198 Windrock Dr, McLean, Virginia.** Also **See Link - propertyiq.com.** A review of loan applications made for the Virginia loans will show what Mills and his spouse claimed as their primary residence. Virginia State and Federal Tax filings and other government agencies in Virginia can provide evidence of what Cory Mills was Doing regarding his residence in Virginia.

February 10, 2023 – Mills and his spouse did a Quit Claim Deed on their Virginia home to the Mills 1198 Windrock LLC and took out a \$2 million Home Equity loan with Wilshire Quinn Income Fund LLC at the same time on the property.

**ADDITIONAL INFORMATION ON THE PERSON WHO COMMITTED VOTER FRAUD in 2021 and 2022**

Mills has several incidents of not paying his federal taxes resulting in 5 separate IRS liens against him (ranging from \$10,000 to \$592,290). He also has been caught lying on multitudes of other issues, i.e., about Graduating from High School, Stolen Valor, claiming he lost his job working for President Trump, pretended he worked for Federal Agencies, etc. Its obvious that he continued to lie to voters about purchasing a house in New Smyrna, and renting the house to his buddy in Winter Park. **See Exhibit 25 - Timeline of Virginia Residency Documentation filed and Florida incidents.**

**REQUEST THAT THESE ALLEGATIONS BE FULLY INVESTIGATED AND CHARGES BROUGHT FOR THESE VIOLATIONS**

It is obvious that Mills kept his residence in Virginia. He committed offenses when he claimed he lived at 973 Wilma Ave, Winter Park, Fl. He committed fraud when he signed a Petition that contained a false address in Orlando. He committed fraud when he put on his candidate donation FEC report that he gave money to Laura Loomer from an incorrect address in Orlando. He committed fraud when he knew he was only renting a vacation home in New Smyrna Beach and lied to voters when he said he purchased it. He Committed fraud when he had a driver bring him to the polls in New Smyrna Beach in a rental vehicle and voted. He knew that when he returned to Virginia just 6 days after the elections, he notified the Virginia Authorities that he was a Virginia Resident. Mills knew what he was doing when he committed these acts. I request that these allegations be fully investigated and that Mills be charged for these numerous acts of fraud. Request that a Grand Jury be put together to further investigate these crimes.

I hereby affirm that the evidence in this complaint is factual to the best of my knowledge.

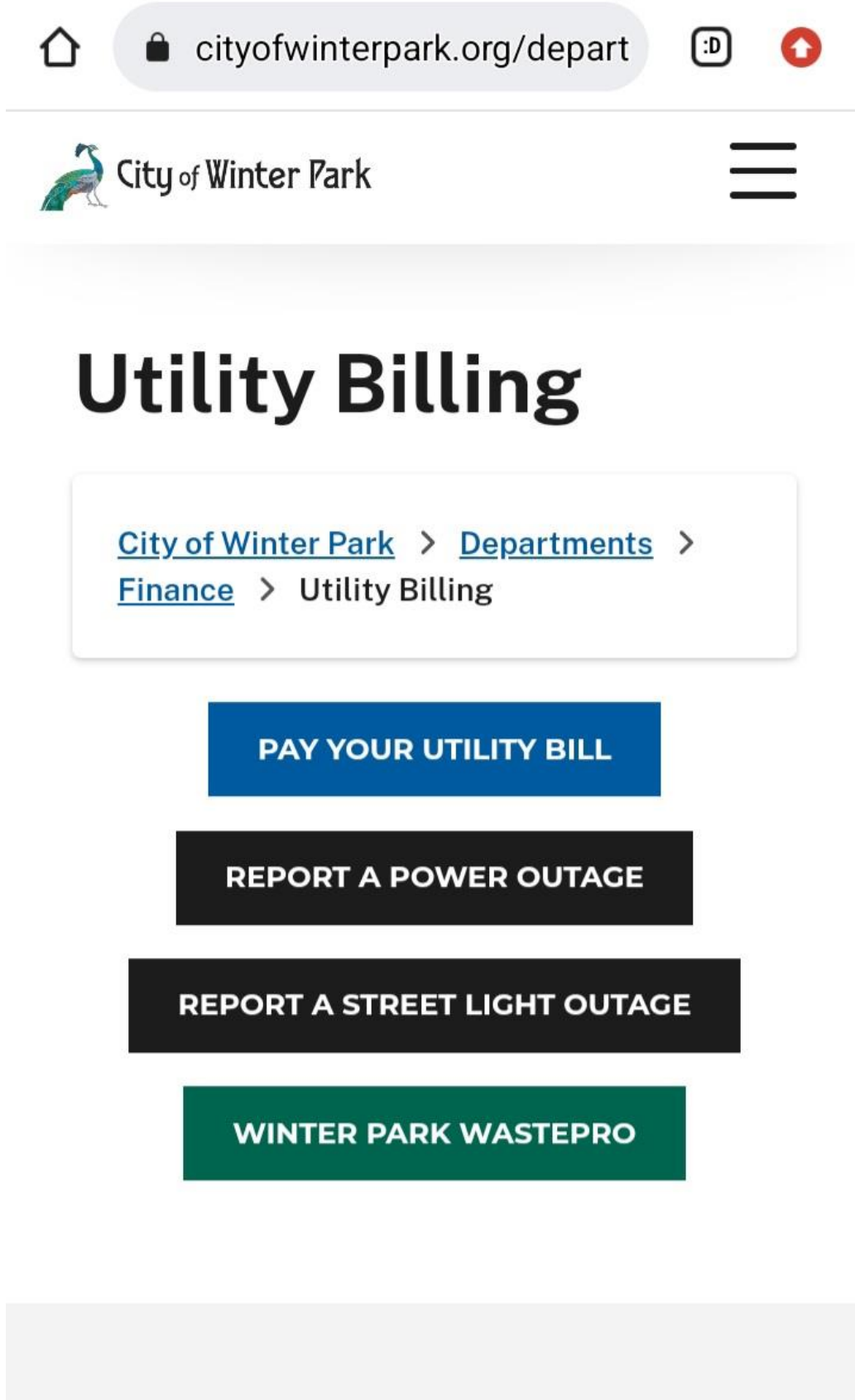

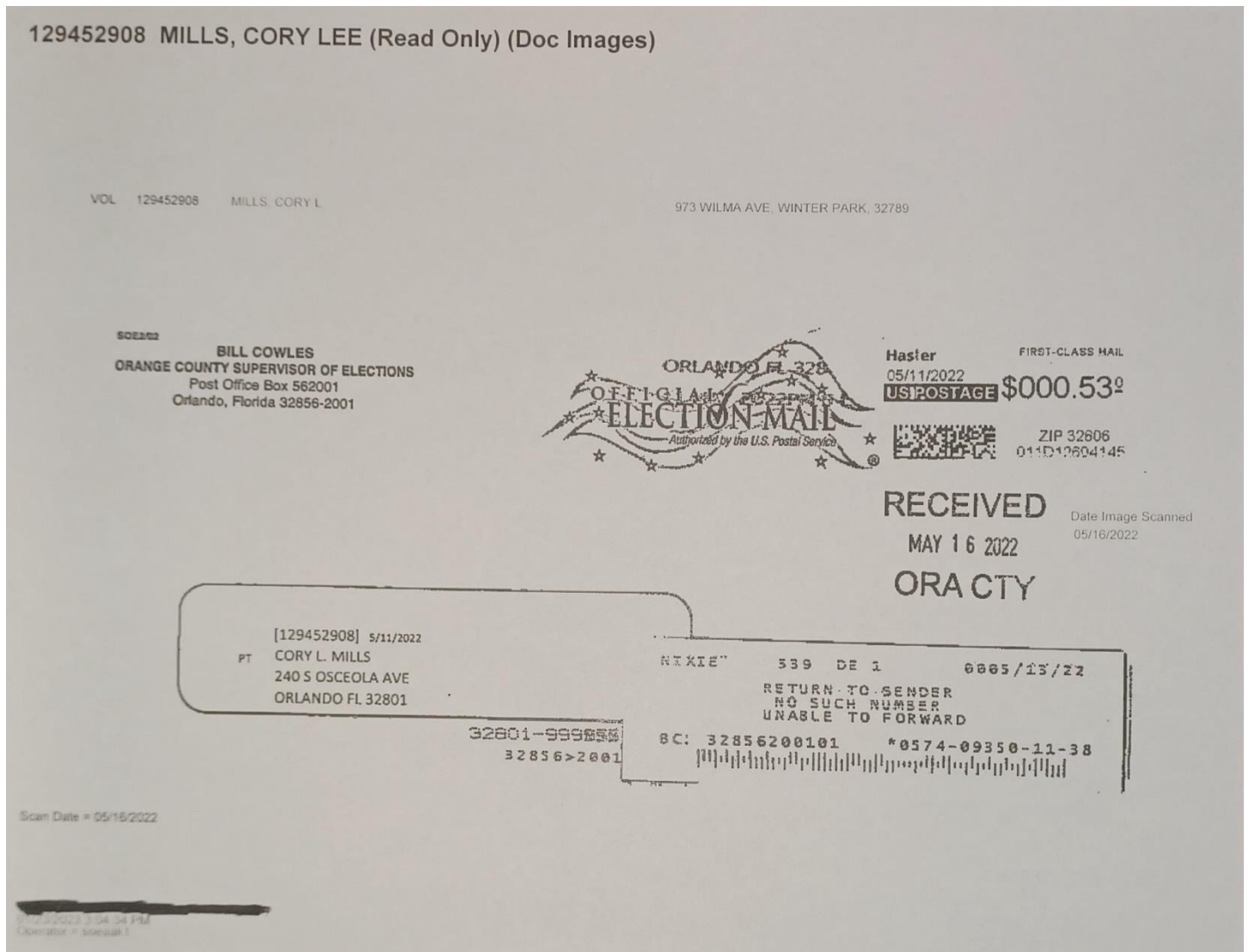
