ANALYSIS of the Cory Mills Campaign for FEC Reporting

Cory Mills is \$1,898,900 in debt to his campaign. Complaints have been filed with the Federal Elections Commission (FEC) on the source of the funds for his loan(s) for that amount of money. The banking Institution(s) are not identified on his Congressional Financial Disclosure Forms.

Cory Mills signed for a Foreign Loan with WAYGAR CAPITAL INC., out of Toronto, Canada, 28 May, 2021. That loan replaced 2 previous loans that he had signed for in late 2018 using his primary residence and the Perry, Florida small business as collateral to purchase the Florida business in October 2018. Mills was also given a \$2.5 million Promissory loan by the National Presto Industries, Inc the sellers of Amtec Less Lethal Systems, Inc.

WAYGAR CAPITAL Inc is a high-risk lender and a foreign corporation. On the loan application and on the loan, documents signed in May 2021 that are filed in the public records of Fairfax, Virgina and Taylor County, Florida, state that Cory Mills Primary residence is 1198 Windrock Dr, McLean, Virginia.

Mills reported on his Congressional Financial Disclosure Report in May 2021 that he had between \$115,000 to \$300,000 in total checking and savings, etc. Just a few days later he obtained the foreign loan and promptly put \$201,000 into his campaign. Mills continued to report putting money into his campaign after that for a total of \$1.8 million.

The loan was renewed and increased in February 2022 and Mills promptly put more money into his campaign in 2022. The loan documents continued to state that Mills primary residence was Virginia. Also, business filings in Virgina during that time and after the election show Mills telling the Virginia Authorities that he was a Virginia resident. In 2019 Cory Mills' wife was given public notice by the Internal Revenue Service (IRS) that a lien was filed on "her" business for \$209,000.00.

During the campaign In June 2021 another IRS lien for \$111,815.00 was placed on the Mills LLC Pacem Solutions International LLC and another one in February 2022 for \$592,278.00. Note that prior to 2018 Cory Mills had another three IRS liens for not paying his taxes. Mills also had two lawsuits against him for not paying HOA fees and for not paying his mortgage.

In addition to the IRS liens placed on the properties recently, Mills had Mechanics liens placed on his residence in Virginia for \$49,000.00 and another one on the Perry, Florida Property for \$299,000.00 for not paying contractors. Plus, another Mechanics lien for \$194,800 was placed on his Pacem Solutions International LLC office in July 2020 and re filed in November 2020.

During the 1st Qtr of 2023 (February) Mills and his wife filed a Deed with the Clerk of the Court, Fairfax, VA transferring their residence with the statement on the document, "who are residing at 1198 Windrock, McLean, Virginia…" to Mills

newest LLC that he filed to create in Virginia in November 2022 telling authorities that he was a Virginia resident at that time also. (just six days after his election in Florida)

Mills also owes a large amount of debt to those he used as vendors for his campaign. See FEC Form 3. His campaign committee is reported to have \$68,883.69, as of month ending June 2023, but that does not take into consideration the debts that he owes for the campaign vendors.

Most of the donor funds for his campaign are coming from outside the state of Florida. A huge portion of his expenditures are going to his travel and lodging.
