

Almost all the campaign money spent the 2nd quarter is being spent for out of state entities and persons except for \$43,000.

The money being spent in Florida is shown here.

The first item was paid to his congressional scheduler, Derick Augustin. Derick and his wife own the bungalow where Mills told Florida officials he lived at from March 23, 2021 thru June 27, 2022.

Other Florida expenditures are for Travel and lodging, very expensive lodging, and limo service in April.

The KGT Global (LLC) is interesting and the person associated with it according to Sunbiz.org is GUILFOYLE, ANTHONY, who is deceased and was a friend of Governor Newson of California.

The Victoriam Consulting LLC is not shown as a Florida LLC in official records and Mills only shows a PO Box. Many questions which are being investigated.

Mills is running his campaign out of Virginia with vendors mostly in north west Virginia.

Mills Campaign and his Victory Fund are both reporting receiving the same amount of money from the same donors at the same time.

Mills spent almost \$90,000 on travel, hotel, and misc. expenses during the first 6 months.

At the end of the 2nd Quarter Mills owed several Campaign Venders over \$368,743.

Mills also is carrying over his \$1,898,900 loan that he reportedly made to his campaign (source of funds is being investigated, because the source is not reported in his Financial Disclosure Reports)


